## Information Box

### Creative Ministry with Children & Youth Fund

The Creative Ministry with Children & Youth Fund of The Presbyterian Church in Canada assists sponsoring groups in planning new one-time or ongoing ministry projects.

#### Criteria for accessing the Fund

Priority is given to projects that meet many of the following criteria.

The ministry:

- is innovative and creative;
- is a new initiative or continues a former initiative in a new way;
- expresses the good news of the Gospel to churched and unchurched children and youth;
- is an articulated and supported ministry of the congregation (or sponsoring body) and is provided with funds by the congregation or sponsoring body;
- at least  $\frac{1}{3}$  of the funding comes from the sponsoring body;
- may be a one-time or an ongoing project;
- encourages the building of solid family life;
- helps young people develop as Christ's disciples.

#### Conditions of disbursement

- The Fund could cover up to, but not more than,  $\frac{2}{3}$  of the cost for the project. The rest will be covered by the sponsoring body. Sponsoring bodies will supply a proposed budget for the project.
- This is a one-time grant to establish new initiatives. However, the Vine Advisory Committee reserves the right to be flexible in granting a two year grant.
- The maximum that any one project may apply for is \$8,000, although The Vine Advisory Committee reserves the right to increase this amount if the project warrants it.

Decisions for the distribution of this Fund will be made at regular intervals by The Vine Advisory Committee. Administration of this fund will be the responsibility of The Vine staff.

#### Expectations after receiving the grant

Within four weeks after the conclusion of the project, or, in the case of longer projects, after one year, a description and photographs must be sent to *The Vine*. This enables your story to be shared with the rest of the denomination.

We ask that your church or organization's contact information be made available so that other Presbyterian Church in Canada groups may benefit from your experience.

#### Continued contributions to the Fund

A quarter of a million dollars has been given to seed this new endeavour. All contributions to this Fund will be fully utilized within seven years of receipt.
