



**THE PRESBYTERIAN CHURCH IN CANADA
PULPIT SUPPLY INSURANCE**

The Presbyterian Church in Canada will provide a pulpit supply insurance plan to all congregations where a full-time professional church worker position for a minister has been established by its presbytery.

The benefit under the plan is up to \$150.00 + travel (\$25.00 maximum) per Sunday for the period of coverage (see page 222 of 1991 Acts and Proceedings).

The benefit will be paid for the first Sunday if the cause of the minister not being able to perform his/her duties is accidental.

The benefit will be paid for the second Sunday if the cause of the minister not being able to perform his/her duties is illness.

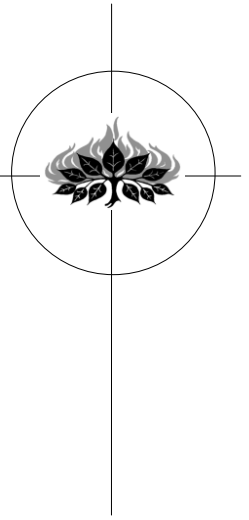
The maximum period of benefit will be the seventeenth (17th) Sunday.

A claim will be made on the prescribed claim form by the congregation employing a minister enrolled in the Health and Dental Plan of The Presbyterian Church in Canada. Any payment due will be directed to the congregation. Pulpit Supply Claim forms are available from The Pension and Benefits office.

The premium due for provision of this benefit is included in the premium charged for the Extended Health Care and Dental Insurance Plan.
